Rate information - The interest rate on this account is 0.500% with an annual percentage yield of 0.50%.

Compounding frequency - Interest will be compounded semiannually.

Crediting frequency - Interest will be credited into this account semimonthly.

Time requirements - This account matures 18 month(s) after account opening.

Early withdrawals - On certificates of less than 12 months we may impose a penalty of 30 days' interest.

On certificates of at least 12 months but less than 24 months we may impose a penalty of 90 days' interest.

On certificates of 24 months or more we may impose a penalty of 180 days' interest.

Withdrawal of interest prior to maturity - The annual percentage yield is based on an assumption that interest will remain in the account until maturity. A withdrawal will reduce earnings.

Automatically renewable account - Your account will automatically renew at maturity. Each renewal term will be the same as the original term, beginning on the maturity date. Unless we tell you otherwise in writing, the interest rate will be the same we offer on new certificate of deposit accounts on the maturity date which have the same term, minimum balance (if any) and other features as the renewed certificate of deposit account.
